


1 - Defining Intersectional Environmentalism

What is intersectional environmentalism?

Intersectionality presents a comprehensive framework for addressing the complex challenges of our modern society. By acknowledging the interconnections among social, economic, and environmental issues, it emphasises that these challenges cannot be effectively tackled in isolation.

The term intersectionality recognize that individuals possess multiple intersecting identities, such as class, gender, ethnicity, religion, physical appearance, sexuality, ability, and more. These identities shape their experiences, exposing them to varying forms and layers of oppression or privileges.



In the context of environmental protection, intersectionality is built on this aforementioned premise. It relates to the recognition that such issues are never only about the environment, per se, but are inherently rooted in our power structures and history. These are key factors that shape our decision-making process which, frequently, evaluates only a small portion of the population's needs or side of the globe. Here is where intersectionality comes into play, to mitigate this widespread approach.



Intersectional Environmentalism

<u>The origins of</u> <u>"intersectionality"</u>

" If you see Inequality as a "them" problem or "unfortunate other" problem, that is the problem"

Kimberly Crenshaw, a prominent scholar of critical race theory, coined the term "intersectionality" in 1991 to describe the unique experiences of African American women who faced multiple forms of oppression within the feminist movement. She highlighted the shortcomings of feminism at that time, pointing out that it failed to incorporate the perspectives of women from diverse backgrounds, including different social classes, ethnicities, sexual orientations, abilities, and more. The feminist movement was predominantly centred around the experiences of white, middle-class, heterosexual, able-bodied women, both consciously and unconsciously, neglecting the realities of other marginalized groups. Crenshaw emphasized that not all forms of inequality are the same, and called for a more inclusive and intersectional approach to address the various layers of oppression faced by different individuals.

Intersectional feminism is a "prism for seeing the way in which various forms of inequality often operate together and exacerbate each other". With this statement Crenshaw recognizes that distinct types of discrimination and privilege do not exist in isolation, but rather interact and overlap, resulting in complex and frequently compounded experiences of oppression and marginalization.

2 - Intersectionality -A paramount approach to Sustainability



Intersectionality in the context of sustainability, advocates for the fulfilment of the present needs without jeopardising the needs of the future generations. Simultaneously, it recognises the interconnectedness of various social identities such as ethnicity, gender, class, ability and their relationship with challenges. environmental More specifically, it takes into account how different forms of oppression, such as racism, sexism, and classism, intersect with environmental degradation. This is an inclusive version of environmentalism that advocates for both the protection of people and the planet. Therefore, it pays attention to particular structures and power dynamics which social are reflected in the effect and management of environmental challenges.

The effects of the environmental crisis are not uniform as they the affect proportions of the population differently in terms of the ability to adapt, mitigate and survive. Hence, Intersectionality acknowledges that they should not be treated in the same manner – rather, by framing strategies that apply a variety of ideologies and approaches to promote greater respect for the planet and its inhabitants. As it identifies the ways in which vulnerable groups are often more affected by these issues, it also questions whether the different experiences and needs of the most marginalised are taken into account or silenced in the design of policies and solutions.

One example of this is the effect of climate change on vulnerable communities, such as Indigenous people. These communities have a deep connection to their lands and rely on their traditional practices for sustenance. However, they bear a disproportionate burden of the consequences of climate change, including the loss of biodiversity, the disruption of ecosystems, and the encroachment of extractive industries on their territories. These threats not only endanger their cultural heritage but also undermine their livelihoods and overall wellbeing.

Therefore, intersectionality fosters solutions that not only address environmental degradation but also work towards social justice, equity and inclusivity.



Fields of intersectionality

Intersectionality is a vast term that can be applied in a myriad of contexts. Within the field of intersectional environmentalism, UR principally focuses on the following topics:

- Climate justice
- Indigenous Rights and Land Stewardship
- Gender and environment

<u>Multi-use of Intersectionality for</u> <u>a sustainable future</u>

Analytical tool

Firstly, intersectionality can be used as an analytical approach to problem-solving. Applying an intersectional lens in research allows for identifying problems from different perspectives and analysing who benefits and who loses from proposed solutions.

Policy tool

Second, intersectionality can be used as a policy tool to facilitate the implementation of democratic and inclusive interventions.

Legal tool

Lastly, intersectionality can be used as a legal tool that promotes human-rights-based approaches in environmental justice cases. Examples of intersectionality guidelines are provided under "Policy guidelines and principles" (page 26).

3 - UR's commitment to Intersectionality



<u>3 - Long- term solutions</u>



Policy guidelines and principles

Inclusive participation and representation
